TREASURER'S REPORT

Council members reviewed the Budget vs Actual Statement for the General Fund for the eleven-month period ending May 31, 2016, the Balance Sheet and the City's List of Investments for the General Fund as of May 31, 2016, the Budget vs Actual Statement for the Road Fund for the eleven-month period ending May 31, 2016, the Balance Sheet and List of Investments for the Road Fund as of May 31, 2016, the General Ledger and the Check Register from May 1 through May 31, 2016.

POLICE REPORT

Police Chief Richard Frank briefed council members on recent activities throughout the city including two reported thefts at Fitness 19. Seven citations were issued this month.

OLD BUSINESS

SANITATION CONTRACT

Council members reviewed the sanitation bids which were opened on June 10. Rumpke was the only bidder and various options were offered. Following discussion, it was moved by Ms. Berger and seconded by Mr. Levy that the City of Northfield accept the following option:

Solid Waste - rear-door pickup - two times per week

Recycling - curbside - one time per week

Yard Waste - curbside - one time per week

ORDINANCES

Ordinance 16-02 adopting an Investment and Financial Management Policy for the City of Northfield had a second reading. It was moved by Mr. Rhea and seconded by Mr. Levy that this ordinance be adopted. Council members voting in favor of this motion: Berger, Birch, Levy, Rhea, Walker and White. Motion carried.

Ordinance 16-03 adopting a 12-month budget for the fiscal period ending June 30, 2017, had a second reading. It was moved by Mr. White and seconded by Mr. Levy that this ordinance be adopted. Council members voting in favor of this motion: Berger, Birch, Levy, Rhea, Walker and White. Motion carried.

Ordinance 16-04 providing for the levy of ad valorem taxes for city purposes for the fiscal period ending June 30, 2017, had a second reading. It was moved by Ms. Berger and seconded by Mr. Walker that this ordinance be adopted. Council members voting in favor of this motion: Berger, Birch, Levy, Rhea, Walker and White. Motion carried.

Mayor Chappell announced that the Northfield Picnic will be held on Saturday, September 10, 2016.
