MINUTES

TREASURER'S REPORT

Council members reviewed the Income Statement for the General Fund for the month ending August 31, 2019, the Balance Sheet and the City's List of Investments for the General Fund as of August 31, 2019. They also reviewed the Income Statement and the Balance Sheet for the Road Fund for the month ending August 31, 2019, and the General Ledger and Check Register from August 1 through August 31, 2019.

POLICE REPORT

Police Chief Richard Frank briefed council members on recent activities throughout the city and reported that five citations were issued in August.

OLD BUSINESS

DOMINION DEVELOPMENT

City Attorney John Singler led a discussion related to the lighting at the Dominion Development. Mr. Singler believes that Dominion has complied with the Metro Land Development Code and will obtain a copy of the compliance certification for the city.

SPEED HUMPS

The possibility of speed humps throughout the city was discussed. Mr. Singler distributed and reviewed a proposed Speed Hump Ordinance which council members will study and discuss again at a future meeting.

KLC INVESTMENT POOL

Both Mr. Singler and Mr. Veeneman summarized the KLC Investment Pool program. Mr. Singler will update Northfield's current investment policy to increase the city's investment capability in accordance with recent KRS updates.
