SANITATION CONTRACT

Mayor Chappell announced that the City of Northfield's new sanitation contract with Ecotech has been completed. The recycling roller bins have been distributed and service will begin July 1, 2021.

MINUTES

TREASURER'S REPORT

Council members reviewed the Income Statement, the Balance Sheet and the City's List of Investments for the General Fund as of May 31, 2021. They also reviewed the Income Statement and the Balance Sheet for the Road Fund for the month ending May 31, 2021, and the General Ledger and Check Register for the period from May 1 to May 31, 2021.

CLERK'S REPORT

POLICE REPORT

Police Chief Richard Frank briefed council members on recent activities throughout the city including a robbery at the AT&T store on U.S. 42 and the theft of cigarettes from the Thornton Store at 4900 Brownsboro Road. Also, a wallet was taken from a purse at 6500 Glen Ridge Park Place, but was later recovered at a Tarc bus stop at Brownsboro Road and Crossgate. Two citations were issued this month.
